We recommend the room be used for public safety use only; collect cleaning deposit from user; charge a use fee (\$25?); establish priority use as EOC.

Mark Thayer, Chairman of the Board for the Alexander Valley Medical Center is present tonight. He is requesting the use of the room to hold a meeting of their foundation for the medical center. Board approved a one time use of the room considering the connection to public safety. Chief Elliott to provide a draft policy to be reviewed by the building committee.

Director Avansino moved and Director Green seconded the motion to approve the Alexander Valley Medical Center, a federally designated rural health center, a one-time only use of the training room due to the absence of a district policy.

TRAINING ROOM

Staff requests direction from the Board of Directors regarding use of our training room. We provide the following staff concerns/suggestions and await your direction:

- Limit the use of the facility to public fire, police or EMS agencies only. Although this is a public building, the area in question serves as the community's emergency operations center and should be used by public officials only. Any exceptions should go to the Board of Directors for determination.
- Require a cleaning deposit of \$250.00 for any use other than our own personnel. Create language that details how the deposit is to be made and justification for keeping the deposit for cleaning the room.
- Charge a \$25.00 use fee which will be deposited into a building maintenance fund. This room will require the most frequent carpet cleaning and eventual carpet replacement.
- Require any agency, other than our own, to provide proof of insurance showing the Cloverdale Fire Protection District as the "additionally insured".
- Establish the priority for use criteria and detail that the use of the facility can be declined or canceled at the discretion of the fire chief or Board of Directors. This might only occur in the event of a disaster where the room needs to function as the EOC.

BUDGET

Staff will have met regarding the budget and an update will be provided to the Board at your meeting. The budget sub-committee will then meet and review staff's suggestions. We would like to bring you a preliminary budget draft at our April 12, 2010 meeting with the intent to have a completed preliminary budget in May.

BUILDING

We are still working through some issues with the station but are receiving adequate cooperation from the contractors involved. Our project came in 8% over budget. This was construction costs only but is under the 10% contingency we placed in the project. Consultants costs have not been finalized and the total project costs are not yet available.
