2. Resolution 14-10 approving the 2010-2011 Preliminary Budget.

Chief Elliott reported the preliminary budget reflects the anticipated reduction in revenues, discontinuing the Amador contract, and not funding the 40-hour position. Revenues are \$200,000 less due to new funding mechanism and reduction in property tax revenues. The budget committee and staff reviewed the preliminary budget. MOU costs and various line items were discussed.

Director Hill moved and Director Green seconded the motion to approve the 2010-2011 preliminary budget.

 - iv. Next liaison meeting to be held in September.
